Other details of the programme	Master Program in Management of Public Health was established in 1997 in the framework of International project TEMPUS. This is up to now the only program in Lithuania, integrating public health and management fields. Two forms of the study program enable students to combine their professional careers and studies. The purpose of the program is capacity building for health system, through training specialists in public health management practice, research, and teaching. Graduates can continue studies for doctoral degree. During the program, competences are developed in the assessment of health determinants and health status of population, planning and implementing of health promotion measures, evaluation of health systems and health reforms, assessment of the activities of health services. Graduates are empowered to integrate public health and management competences in the process of leading and managing health care and related institutions, aiming at health improvement

	of the population.
